Purpose

The Harrup Park Charitable Contributions Fund has been established to provide on-going support to the local community in which we operate.

The Harrup Park Charitable Contributions Fund will provide direct grants for community welfare through charitable organisations and eligible individuals to help make our local communities a better place to live, work and play.

To that end, the Harrup Park Charitable Contributions Fund supports the efforts of charitable organisations and individuals, particularly those with limited resources.

We welcome and invite applications from eligible Not-for-Profit organisations that provide vital local services within the Mackay region, and individuals in the areas of childhood/ youth, people with disabilities, environmental care and social/communiy welfare.

Eligibility

Applicants must demonstrate that they fall within the following eligibility guidelines:

- The applicant is a community-based Deductible Gift Recipient; and
- The applicant provides services to the Mackay community. / or
- The applicant can demonstrate need.

Ineligible Organisations

- Sporting organisations with reasonable demonstrated income.
- Organisations who benefit from alternative annual contributions from MCA, HPCC or any other community club.

Ineligible Projects Include

- Annual fundraising appeals.
- Overseas travel.
- Projects which are more suited to corporate sponsorship or government funding.

Assessment

Applicants will be required to submit both an Application Form and written Funding Submission. The Funding Guidelines will assist you to determine your organisation's eligibility for an Harrup Charitable Contributions grant.

The written Funding Submissions should include an outline of the proposal stating the specific details of funding required and how it will be used. Your submisison must not exceed two (2) A4 pages in length including supporting documentation (ie: letters of support, testimonials).

This information will be assessed by the Harrup Park Charitable Contributions committee and board of MCA who will take into account applicant's current financial position to assist in establishing a priority of need.

Funding Guidelines in Receiving a Grant:

- Application is eligible to receive funding.
- Application meets a significant and demonstrable need in local Mackay community.
- Application is based on sound research and has a strong likelihood of meeting its objective.
- Incomplete applications will not be assessed.
- If time constraints apply to the funding, this should be noted in your application.
- Receipt of funds enable HPCC to promote via channels.

Preparing the Written Funding Submission Application:

Preparing details about your application in a maximum of two (2) A4 pages or less including:

- A brief history/profile of your organisation, including its objective and the activities it conducts;
- Then number of volunteers and/or paid employees in your oragnisation;
- What benefit will be gained from the funding, including who it will aid and how the local community will benefit from project; and how it will be distributed.

- Provide information that will outline and support your organisation's achievements to date; and
- Provide details of any other financial support your organisation receives.
